

At the October luncheon we introduced a new special placard at each table called "Did You Know?" which provided details about the 2018 Book Sale. I hope to follow up with more information each month. This month's "Did You Know?" is printed on page 7.

Lately I have been thinking about the letter M and our branch. Does M stand for Membership or

Mission? Kimberly Churches, AAUW CEO, says that M stands for Mission. I, also, have been known to stress mission over members, but I am now thinking that we can't accomplish our Mission, equity for women and girls, without valuing our members. We have a wonderful group of women in our branch. One of the things that strengthens our ability to move our mission forward is our diversity.

I know that many of you do not think we are a very diverse group, but I beg to differ. We certainly are diverse in our ages, our past lives (careers or stay at home mothers) (city or rural backgrounds), our educational backgrounds, [women with multiple degrees, and women who married upon completion of high school entering college at a later date). We have women who have changed careers assembling multiple skill sets as they moved on.

We are diverse in our interests. (Look at our many study/interest groups - would you be comfortable in all of them?). And we are also diverse in our political views.

We differ in many ways, but we agree on the basic mission of equity for women and girls, and we do what we can to help move that mission forward. I firmly believe that we can accomplish great things if we work together. When we look around and see an injustice, and say, "Somebody should do something about that," we should look in the mirror. I am somebody and you are somebody. Let's pick a cause and do something.

One area that we are looking at is "Women in Transition." (WIT)



You may remember that we sponsored WIT conferences several years ago. At those conferences women were given information on how to get a GED if they did not have a high school diploma, how to work with Michigan Works in looking for jobs, how to fill out an Application for Federal Student Aid (FAFSA) if they would like to go to a college (community or four year), and how to apply

for apprentice programs with the various unions.

We disbanded the WIT program because jobs and apprentice programs were not available at that time. The economy has changed now. Unions are looking for apprentices, and the government is trying to find ways to fill jobs and keep people living in our communities. We have applied for a grant from the Village Club Foundation to help fund this activity. We can also look for other partners to help us. In the fall of 2019, a restarted WIT conference will be a great way to kick off our branch's 100-year celebration.

Let me know what you think about this idea, and maybe you have some additional ones.

#### Highlights of the Wednesday, October 10, 2018 Board Meeting

- Sue Longstreet submitted a financial report as of 9-30-18, at which time the total assets of the branch were \$27,835.99 and net assets were \$27,835.00.
- The following charities were suggested as possibilities for luncheon donation items: Bound Together, Crossroads of Michigan, and Big Family of Michigan.
- Dues treasurer Karen Boyk reported that we have 241 members and requested that study group leaders check to be sure that all people attending their meetings are members.
- A new member tea is planned for Friday morning, November 30th.
   New members, board members, study group leaders, book sale chairs and Explorathon chairs will be invited.
- Diversity chair Catherine Hurley announced that the November community outreach study group will meet at the Big Family of Michigan located in St. Clair Shores and wrap gifts for the holidays.
- A grant application has been submitted to support a Women in Transition Conference (WIT) in fall, 2019. WIT is designed for women who seek training and knowledge to further their career options. (see President's letter pg. 2)
- Education Equity representative Cindy Clement reported that schools in Detroit are experiencing enrollment instability due in part to children being moved too often within the district. Enrollment instability impacts student performance.
- Bylaws and Policy chair Christine Lapinski distributed an updated policy index sheet and a new table of contents for board member notebooks. All branch policies and procedures are now available on line.

# HOPE YOU VOTE YES ON TWO NON-PARTISAN PROPOSALS

#### Proposal 2: Voters not Politicians:

Politicians are elected in districts. Where you vote and who you vote for is determined by the district you live in. Every 10 years a national census is conducted, and the new population data is used to redraw district lines to accurately reflect populations changes. In a perfect democracy, this process ensures that each vote counts and that voters' voices are heard. Gerrymandering happens when politicians draw district lines to benefit their political party, by using voters' personal information and highly advanced computer algorithms to draw the district maps. This proposal aims to create an Independent Citizens Redistricting Commission to redraw district maps that allow voters the ability to choose their politicians. #### Proposal 3: Promote the Vote:

A proposal to amend the Michigan Constitution of 1963 by amending Article II, Section 4. The proposal would provide citizens qualified to vote in Michigan with the following rights: to vote a secret ballot; for military and overseas voters to be sent a ballot 45 days before an election; to vote straight party on all partisan general election ballots; to be automatically registered to vote when obtaining a driver's license or personal identification card from the Secretary of State, unless the person declines; to register to vote by mail on or before the 15th day before an election; to register to vote in person at any time with proof of residency; to vote an absentee ballot, by mail or in person, without giving a reason; and to have election results audited to ensure the accuracy of elections.



# SPOTLIGHT ON OUR NEWEST STUDY/INTEREST GROUP - COMMUNITY OUTREACH

Our second Community Outreach Program is scheduled for Thursday, November 15th at 10:30 am at Big Family of Michigan in St Clair Shores. (Our first program was providing a summer lunch for children at Crossroads of Michigan in August.) This time we will be wrapping presents for a holiday gift program. Gift bags are put together for

each child which include a jacket, blanket, hat and mittens, book, toy, game, clothing and an item or two from their wish lists. The goal is to provide gifts for 1800 children across Michigan covering 43 counties including counties in the U.P. All of these gifts need to be wrapped Get your fingers ready to work!

The center is located in an old elementary school. The address is 23500 Pare Street, St Clair Shores, Mi 48080. We can organize car pools so everyone doesn't need to drive a car there. If you want to donate a gift, you are welcome to bring something that day. We will be collecting for this organization at our December holiday luncheon meeting also.

Big Family of Michigan (BFOM) is an organization begun by Jeanne Fowler in 2002, working out of her garage to prepare Birthdays in a Bag for foster and abused children. Today it continues to serve abused, foster and institutionalized children, and recently they have added support to children being raised by grandparents. In Michigan alone there are 142,000. children being raised by grandparents, and 29% of those grandparents are living in poverty.

I hope we get a good turn out for this activity. It is a chance to help out a wonderful organization, bring joy to some needy children, and socialize with members as we work. #### 2018 USED BOOK SALE UPDATE





Well over one hundred members participated in the used book sale either sorting and picking up books from barrels at various sites during the summer, setting up for the sale, cashiering, helping in the kitchen, assisting customers, making boxes, tearing down boxes, donating dollars, helping with the packing of left over books, or any number of various activities necessary to make the sale happen. This is a huge undertaking, and the response of our members is necessary to bring it all together.

A profit of about \$10,000 was generated. Our scholarship obligations are around \$13,000 so we have to bring in some more funds to avoid reducing our educational support. Let's look forward to the Gala in May to help with the scholarships.

Seventy-five teachers selected 3,520 books totaling \$4,126.00 in free books given to area classroom teachers. Thank you to our members for donating to the Patron/Donor Fund to help support this philanthropy for educators.

A total of 11,965 books were sold or donated to charities. We began with 16,779 books that were collected and sorted during the summer. Books came from barrels at three ACE Hardware stores, three Hollywood Markets, the Bloomfield Township Senior Center, two Market Square Markets, a beauty salon, home pickups, and books dropped off at the sorting site.

William Stephenson was a very necessary help taking unwanted books to SOCCRA for recycling and helping every day of the sale. John Longstreet was invaluable with his assistant, Sue, loading, unloading and loading again and unloading again shelving, boxes, carts, etc., before, during and after the sale.
